### From the Executive Director's Desk

Happy New Year! We wish you much success in your sports and activities programs throughout 2025.

We would like to express our sincere gratitude to the administrators who participated in the classification questionnaire. With 80% of our member schools contributing valuable insights, the Board of Directors now has the necessary data to evaluate potential adjustments to the classification policy in the coming months.

As a result of this review, the Board has decided to delay the establishment of classification cut-offs for the 2025-2026 school year, which will not follow the timeline outlined in the current policy guidelines. Notifications regarding the 2025-2026 classification cut-offs will be issued once the Board has determined whether any changes will be made to the policy. Additionally, the Board will await the final enrollment data for the 2024-2025 school year from the Illinois State Board of Education (ISBE) before making further decisions.

With the Board's approval of a return to an annual classification cycle, the most current enrollment data from ISBE will be used to determine classification. Therefore, the 2024-2025 enrollment figures will be used to establish classifications for the 2025-2026 school year.

## By-Law Breakdown – New By-Laws

All nine by-law proposals that were on the by-law referendum ballot last month received a majority vote of the membership for passage. While most will go into effect on July 1st, three of the nine by-laws were proposed to go into effect thirty days after the vote. See the breakdown below for the three by-laws in effect as of January 16th, 2025.

### By-law 2.080 – Selection and Use of Licensed Officials

When it is found that an unlicensed official has worked a contest, the official shall be suspended for the remainder of that sport season. If the unlicensed official was scheduled by an assignor, the assignor shall be placed on probation. All member schools shall be notified of the official who is out of compliance. At the beginning of each season, the IHSA office shall send member schools a list of all officials who have had a lapse in their license.

### By-law 2.180 – Travel Policy

When a school team travels out of state for competition, participating students can miss up to four total school days, including travel to and from competition, per season.

### By-law 3.153 – Special Provisions for Summer Participation

School coaches may have a maximum of [20 contact days](#) with students during the summer in each sport. A contact day is defined as any date that includes coaching or instruction in the skills and techniques of the sport or any organization of sport-related activities or competition outside of weights and conditioning.

Coaches may continue to conduct strength and conditioning workouts that are not counted as contact days provided there is no coaching or instruction in the skills of the sport. Strength and conditioning workouts are limited to no more than four days per week and no more than 90 minutes per session.

**Reports – Special/SAWA, Concussion, & Yellow Cards (R):** Upon clicking the R button, the Special Reports page will open. All Special Reports filed in the last four years will be listed. The Yellow cards link will show a summary of all yellow cards filed from boys and girls soccer contests in the current and previous school year. Under Concussion Reports, a summary of concussion reports from the last two years will be listed. These reports are submitted by Certified Athletic Trainers or other staff at each school.
